approving the work programme 2021 of the European Climate, Infrastructure and Environment Executive Agency

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EC) No 58/2003 of 19 December 2002 laying down the statute for executive agencies to be entrusted with certain tasks in the management of Community programmes¹, and in particular Article 9(2) thereof,

Whereas:

- (1) Commission Implementing Decision (EU) 2021/173² establishes the European Climate, Infrastructure and Environment Executive Agency ('the Agency') from 1 April 2021.
- (2) Articles 6(1) and 7(1) of Implementing Decision (EU) 2021/173 set out the Union programmes and parts thereof which implementation the Agency is entrusted with.
- (3) Commission Decision C(2021)947 final³ delegated powers to the Agency with a view to the performance of tasks linked to the implementation of those Union programmes and parts thereof.
- (4) Pursuant to Article 10 of Decision C(2021)947 final, the Agency submits a draft annual work programme to the Commission for approval prior to adoption by its Steering Committee.
- (5) The draft work programme submitted by the Agency comprises detailed objectives and performance indicators and complies with the programming defined by the
